12. **Flights:** All flights are subject to change at any time. Australian Sports Tours is not responsible for any involuntary changes made by airlines or other suppliers, which may affect the flight schedule. If Section 5 - Flight Information of the Reservation Form is not completed, the passenger will automatically be booked as Land Only (Land Only passengers join the tour at the first hotel in the destination country). Airport transfers are not included in the Land Only cost. Please note that all flights are booked as a group allocation. If you require specific flight arrangements other than the group allocation, please indicate your requirements at the time of booking otherwise you may incur amendment fees
13. **Alternate Travel Dates:** Any request for an alternate travel date must be received in writing to Australian Sports Tours and is subject to availability at the time of booking. Any change of date from the Australian Sports Tours group departures may incur additional charges, as the group airfare will no longer apply.
14. **Price and Validity:** All prices quoted are based on tariffs and exchange rates current at the time of quotation and are subject to increase without any prior notice consequent upon an increase in the basic tariffs or exchange fluctuations which may take place prior to touring. Australian Sports Tours reserves the right to adjust prices whether or not you have already made full payment. We will do everything within our control not to adjust prices and will generally only amend prices in the event of marked fluctuations in exchange rates, fuel costs and other operating costs on which prices are based. Airfares (except when otherwise stated), passport and visa fees, travel insurance, excess baggage charges, airport taxes, gratuities to leaders and guides, extra meals, laundry, drinks, medical expenses, optional activities and trips, and any items of a personal nature are not included in your tour price.
15. **Itineraries and schedules:** a) All holidays, itineraries, travel arrangements, hotel accommodation, etc are subject to alteration or cancellation at any time without prior notice for any cause which in the absolute discretion of the Company renders it desirable, reasonable or necessary to effect such alteration or cancellation in particular without prejudice to the generality of the foregoing in the event of the revision of arrangements or the imposition of conditions by the restaurant, hotel or transport contractors or managers. No liability of any kind shall fall upon the Company in respect of such alteration or cancellation. b) The Company reserves the right at its absolute discretion to refuse or cancel any booking or terminate the arrangements made for any person or persons at any time without being under any obligation to assign a reason therefore. In the event of the exercise of this right the company shall be under no liability to the person or persons affected save to refund any monies paid by or in respect of such person or persons for such booking or where the arrangements have already commenced to refund such amount as the Company in its uncontrolled discretion thinks reasonable to attribute to the uncompleted portion.
16. **Unused tour services:** Refunds will not be made in respect of unused accommodation, meals, sightseeing tours, tickets, transfers, or any other services which are included in the tour cost but not utilised by the passenger.
17. **Third Parties:** No agents, representatives, conductors or any other passenger's are authorised to have any right to promise to refund any sums paid or to remit any sums payable, either wholly or in part or to agree to any variation of these conditions of booking.
18. **Tickets:** Australian Sports Tours will not be held responsible for the loss, theft, destruction or misplacement of all tickets regardless of the reason.
19. **Frequent Flyers:** Australian Sports Tours will endeavour to pass on Frequent Flyer numbers to the airlines, but where more than one carrier is involved with the flight itinerary, Australian Sports Tours will take no responsibility that the Frequent Flyer numbers will be passed on by the appropriate airlines. Australian Sports Tours recommends retaining all boarding passes in the event that they are required to prove accumulated Frequent Flyer points.
20. **Residential Address:** Australian Sports Tours prefer to use a residential address when sending out tour documents. Documents are sent by courier who provides a secure and fast delivery service. If sending to a post box, documents will be sent via Express Post which is less secure and can cause substantial delays in the delivery process. If any passengers require documents to be sent to an alternate address, Australian Sports Tours will need to be notified in writing of this at least 2 months prior to the tour departure.
21. **Minimum numbers:** Minimum numbers may apply to some tours. If minimum numbers are not reached, Australian Sports Tours will notify prospective passenger's and offer optional travel itineraries. If optional travel itineraries are not required a full refund of the amount paid to date will be refunded. Passenger's will be notified within a reasonable time prior to the planned departure date if minimum tour numbers have not been reached.
22. **Passport & Visas:** Australian Sports Tours are not responsible for passport, visa requirements, entry, health or other requirements of the countries visited or for any loss sustained by the passenger for failing to comply with laws, regulations, orders and/or requirements of countries visited. Non Australian passport holders are responsible for arranging any extra visas and re-entry requirements.
23. **Luggage:** Luggage and personal effects are at passenger's own risk. It is stressed that Australian Sports Tours cannot accept responsibility for any loss or damage to passenger's personal luggage or effects from any cause whatsoever, even though handled by Australian Sports Tours servants or agents and it is recommended that luggage be insured for the duration of the holiday or tour.

Responsibility: Australian Sports Tours and / or its associated companies or Agents give notice that they act as booking agent only for the persons or companies providing or offering the means of travel conveyance, transport, accommodation, or other services and all receipts, dockets, vouchers, coupons or exchange orders are issued under the terms and conditions under which transportation and other services are provided. Australian Sports Tours shall not be liable for any injury, damage, loss, accident, delay or irregularity that may be caused or arising during any tour under its management, sponsorship, procurement, or otherwise notwithstanding that the Company's principal may be a foreign company, corporation or person. So far as the company shall not be acting as such booking agent it shall be deemed to be acting as Agent for the person making the reservation. It is the responsibility of the passenger to ensure he or she is in possession of the other travel documents and that they are in compliance with the current government and transportation company's regulations. The transportation companies or firms shall be exempt from liability in respect of any detention, delay, loss, damage, sickness or injury however and by Whomsoever caused and of what ever kind occurring of or to passengers at any time when the passenger is not on board a carrier or conveyance used or operated by the transport companies or firms.
